(2) To empower the Council to charge for water for domestic purposes in the said parishes at a rate not exceeding fifteen pounds per centum per annum on the rateable value of the dwelling-house or part of a dwelling-house supplied;

(3) To authorise the Council to construct and maintain the following additional waterworks, namely : ____

Work No. 1.—A well or wells and pumping station in the Parish of Bagendon in the enclosure numbered 188 on the $\frac{1}{2500}$ Ordnance Map of the said Parish (Edition 1921 Gloucestershire Sheet No. Ll.2).

Work No. 2.—A service reservoir in the Parish of Baunton in the enclosure numbered II on the $\frac{1}{2500}$ Ordnance Map of the Parish of Stratton (Edition 1921 Gloucestershire Sheet No. Ll.2).

Work No. 3.—A waste water conduit in the Parishes of Baunton and Daglingworth commencing in the said Work No. 2 and terminating in the enclosure numbered 12 on
