the 1st day of August and the 1st day of November in every year a fixed annual sum of $f_{2,550}$ to the said Walter Godfrey, Bishop of Saint Edmundsbury and Ipswich, and to his successors in the same Bishopric, as a reendowment of the said Bishopric the first of such quarterly payments to be nade on such of the said quarterly days as shall happen next after the day of such publication as aforesaid and to be a proportionate part of the said quarterly payment calculated from the date of such publication to the said quarterly day of payment. Provided always that, as from the date of such publication as aforesaid, all trusts and provisions for the foundation of a Dean and Chapter previously attaching to the invest-ments and property described in the said Schedule shall cease and determine not only as regards the said investments and property but also as regards the said annual sum of $f_{2,550}$ and all or any the property or income which may hereafter become part of the endowment or income of the said Bishopric of Saint Edmundsbury and Ipswich.

"And we further recommend and propose that nothing herein contained shall prevent us from making any other recommendations and proposals relating to the matters aforesaid or any of them in accordance with the provisions of the said Measure or of any Act of Parliament or of any other Measure of the National Assembly of the Church of England.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Saint Edmundsbury and Ipswich.
