ROAD AND RAIL TRAFFIC ACT, 1933.

NOTICE is hereby given that on the 1st February, 1937, the Minister of Transport confirmed the County Council of the Administrative County of Surrey, Furnace Mill Lane, Lingfield (Restriction) Order, 1936, made by the County Council of the Administrative County of Surrey under Section 46 (1) of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933; the Order provides that:—

Subject to certain exemptions no person shall drive or cause to be driven any heavy locomotive, light locomotive, motor tractor, or heavy motor car (as respectively defined in Section 2 of the Road Traffic Act, 1930, or any Regulation made or to be made thereunder) on the length of the unclassified road called Furnace Mill Lane and locally known as Smither's Lane, Lingfield, from the boundary of the Administrative County of Kent near Smither's Farm to its junction with Shepherds Grove Lane.

NOTICE is hereby given that on the 1st February, 1937, the Minister of Transport confirmed the County Council of Kent Roads (Restriction) Order, No. 4, 1936, made by the County Council of the Administrative County of Kent under Section 46 (1) of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933; the Order provides that:—

Subject to certain exemptions no person shall drive or cause to be driven any heavy locomotive, light locomotive, motor tractor, or heavy motor car (as respectively defined in Section 2 of the Road Traffic Act, 1930, or any Regulation made or to be made thereunder) on the length of the unclassified road known as Furnace Mill Lane, Cowden, from the boundaries of the Administrative Counties of East Sussex and Kent at Furnace Mill Lane, Cowden, via Scarletts Mill and Bazing Farm to the boundary of the Administrative Counties of Kent and Surrey near Smither's Farm.

BOROUGH OF LOUGHBOROUGH.

LOUGHBOROUGH PLANNING SCHEME No. 3.

NOTICE is hereby given that: (1) on the Fourth day of February, 1937, the Minister of Health notified his approval (with modification) of the resolution of the Town Council of the Borough of Loughborough dated the Seventh day of December, 1936, deciding to prepare the above planning scheme with reference to an area situate within the Borough of Loughborough; (2) the Map defining the area to which the Resolution applies has been deposited at the Town Hall, Loughborough, and will be open for inspection by all persons interested without charge between 10 a.m. and 4 p.m. on any weekday except Saturday and between 10 a.m. and 12 noon on Saturday; (3) any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the Borough of Loughborough and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Town Council of the Borough of Loughborough to register without charge his or their name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933,* the development of land in the area during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Town Council of the Borough of Loughborough are empowered to permit other development in the area during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with the aforesaid Map.

The Town Council of the Borough of Loughborough intend to proceed as soon as may be with the preparation of a Draft Scheme and any suggestions as to the proposals to be included in the Draft Scheme should be sent in writing to the Town Clerk, Loughborough.
