SUSPENSION OF WITHDRAWAL OF AUTHORISATIONS.

JOHN ALEXANDER ROSS.

The Home Secretary gives notice that he has suspended until further Order the operation of the Notice, dated 24th April, 1935, and pub-lished in the London Gazette and Edinburgh Gazette on the 30th April, 1935, withdrawing from John Alexander Ross, M.B., Ch.B. (Aberdeen), now residing at 6, Erskine Terrace, Aberdeen (whose registered address is Fernlea, Brora, Sutherland), the authority granted by the Regulations made under the Dangerous Drugs Act, 1920, to duly qualified medical practitioners to be in possession of and to supply raw opium, coca leaves and Indian hemp, and the drugs and preparations to which Part III of the Act applies; and has also suspended the direction, given at the same time, that it should not be lawful for Mr. Ross to give prescriptions for the purposes of the aforesaid Regulations. • :
