1937, and shall come into operation on the 1st day of April, 1937.

(2) In this Order the term "existing subdistrict" means a sub-district which existed immediately before the 1st day of April, 1937.

- 2. That portion of the existing Hailsham South sub-district consisting of parts of the parishes of Jevington and Willingdon which will, by virtue of the provisions of the County of Sussex East (Hailsham, Jevington and Willingdon Parishes) Confirmation Order, 1937, be included on the 1st day of April, 1937, in the parish of Hailsham, shall cease to be included in the Hailsham South sub-district and shall be added to and form part of the Hailsham North sub-district.
- 3. The Registrars of Births and Deaths of the existing Hailsham North and Hailsham South sub-districts shall respectively be the Registrars of Births and Deaths of those subdistricts as altered by this Order.
