1937). The Narcissus Pests (Lincolnshire
(Holland)) Order of 1937.

This Order empowers officers appointed by the Local Authority for the County of Lincoln (Parts of Holland) or the Borough of Boston to examine narcissus plants or bulbs and enables the Local Authority to take action to prevent the spread of infestation with the pests known as Narcissus Flies, Eelworm, or Bulb Scale Mite.

LAND DRAINAGE ACT, 1930.

River Clwyd Catchment Board.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a scheme submitted to him by the River Clwyd Catchment Board, under Section 4 (1) (a) of the Act, for the transfer to the Catchment Board of all such rights, powers, duties, obligations and liabilities over or in connection with the main river as were immediately before the commencement of the said Act vested in or to be discharged by any drainage authority, and of any property held by the authority for the purpose of, or in connection with, any functions so transferred.

A copy of the Order may be seen at all reasonable hours at the Office of the Clerk of the Catchment Board, County Offices, Ruthin, and also at the Offices of the Ministry of Agriculture and Fisheries, 10, Whitehall Place, London, S.W.1.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act, or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

The Tithe Redemption Commission give notice that in exercise of the powers conferred upon them by the Tithe Act, 1936, they have made the Tithe Arrears Rules, 1937, prescribing the forms of notice in which the particulars of the arrears which a tithe owner claims to be recoverable from a tithe payer, shall be given by the tithe owner under Section 20 (3) of the Act, (a) to the tithe payer and (b) to the Commission. The Rules also prescribe the form in which the notice required by Section 20 (4) of the Act shall be served by a tithe payer upon the Commission, requiring the matter of the recovery from him of the arrears to be referred to the Arrears Investigation Committee.
