LAND DRAINAGE ACT, 1930.

River Ouse (Yorks.) Catchment Board.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a scheme submitted to him by the River Ouse (Yorks.) Catchment Board, under Section 4 (1) (a) of the Act, for the transfer to the Catchment Board of all such rights, powers, duties, obligations and liabilities over or in connection with that part of the main river known as the "Scalby Sea Cut" as were immediately before the commencement of the said Act vested in or to be discharged by any drainage authority, and of any property held by the authority for the purpose of, or in connection with, any functions so transferred.

A copy of the Order may be seen at all reasonable hours at the Office of the Clerk of the Catchment Board, Central Bank Chambers, Infirmary Street, Leeds, and also at the Offices of the Ministry of Agriculture and Fisheries, 10, Whitehall Place, London, S.W.1.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act, or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

SEA FISHING INDUSTRY ACT, 1933.

Notice is hereby given that the Minister of Agriculture and Fisheries, the Secretary of State for Scotland and the Secretary for the Home Department, in pursuance of the powers conferred on them by Section 3 of the Sea Fishing Industry Act, 1933, have made an Order entitled:—

The Sea Fishing Industry (Fishing Nets) Order,
1937.

The Order which comes into force on 19th April, 1937, revokes the Sea Fishing Industry (Fishing Nets) Order, 1933, and provides that no fishing boat registered in the United Kingdom shall carry, for the purpose of catching sea fish (other than herrings, pilchards or shrimps) in any waters outside the three-mile limit, any trawl or seine-net, or any other net having a bag or cod-end, which has in any part of the net a smaller mesh than is specified in the Order. The Order further provides that it shall not be lawful to attach to any net to which the Order applies any canvas, netting or other material or to use any other artifice or device so as to obstruct or diminish the size of the meshes of such net.
