Notice as to Counting of Telegrams.

In pursuance of the powers vested in him by the Telegraph (Inland Written Telegram) Regulations 1931, the Postmaster General hereby gives notice that as from the date hereof the rules contained in Regulation 19 (1) of the said Regulations shall be varied in manner following, that is to say, that initial letters or figures or a combination of initial letters and figures indicating a Postal District in the text or in the address of an Inland Written Telegram shall be counted and charged for as one word, except when used in conjunction with the name of a town, in which last-mentioned case they shall not be charged for. Thus:—

(1) Jones, 18 Shakespeare Road, London, N.W. 7. will be counted as five words.

(2) Robinson, 29 Cleaver Street, Birmingham 10, will be counted as five words.
