

"the Act of 1936," "the observation agreement," and "Spanish territory" have the same meanings as they have for the purpose of the Act.

"the International Committee" means the International Committee for the application of the agreement regarding non-intervention in Spain.

(3) The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

2. Any ship to which the Act of 1936 applies and which is bound to a port or place in Spain between Cape de Gata and Cape Oropesa shall pass within a distance of one and a half sea miles of one of the points set out in the schedule to this Order, unless, after that ship has left her last port of call outside Spanish territory on her voyage to such port or place in Spain, an officer of a ship of war which fulfils the conditions specified in section 2 of the Act has, to the knowledge of the master of the ship, verified the identity of the ship and has ascertained whether or not observing officers are on board the ship.

3. If any ship to which the Act of 1936 applies fails to comply with the provisions of the foregoing Article the master of the ship shall be liable to a fine not exceeding one hundred pounds.

4. This Order shall extend to all those parts of His Majesty's dominions and other countries to which the Act of 1936 extends.

1. A point 180°, ten sea miles, from Escobrera Island Light, Cartagena.
2. A point 090°, ten sea miles, from the Group Occulting Light at the southern end of the breakwater, Alicante.
3. A point 090°, ten sea miles, from the Group Flashing Light at the end of the Dique del Norte, Valencia.

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England, in pursuance of the Union of Benefices Acts, 1860 and 1898, prepared a Scheme dated the 7th day of November, 1935, for effecting the union of two contiguous Benefices in the City of London, namely, the Benefice of St. Edmund the King with St. Nicholas Acons, and the Benefice of All Hallows, Lombard Street, with St. Benet, Gracechurch, St. Leonard, Eastcheap, and St. Dionis, Backchurch:

And whereas the said Scheme was laid before both Houses of Parliament for the space of two calendar months:

And whereas Mr. P. A. Molteno of 10, Palace Court, London, W.2, stated in writing by way of protest an objection to the said Scheme:

And whereas the Royal Academy and others petitioned His former Majesty King Edward the Eighth in Council against the said Scheme:

And whereas the Ecclesiastical Commissioners certified the Scheme and the necessary consents thereto in writing to His said former Majesty in Council:

And whereas the Corporation of the City of London showed cause to the Ecclesiastical Commissioners against the said Scheme and appealed to His said former Majesty in Council against the said Scheme:

And whereas the said Appeal, Petition and Objection were referred to the Judicial Committee of the Privy Council by Order in Council of the 28th day of May, 1936:

And whereas the Lords of the said Committee, having taken the said Appeal, Petition and Objection into consideration and having heard Counsel on behalf of the Appellants and Petitioners and Objector and the Ecclesiastical Commissioners for England and the Ecclesiastical Commissioners for England by their Counsel undertaking that subject to Section 14 of the Union of Benefices Act, 1860, all fittings in the Church of All Hallows, Lombard Street, which they might be advised by competent authority to be worthy of preservation should if suitable for the new Church of All Hallows to be erected be placed therein and no such fittings though unsuitable for that Church should be sold, reported to His Majesty as their opinion that the said Scheme ought to be affirmed:

And whereas His Majesty was pleased, by and with the advice of His Privy Council, by Order in Council of the 13th day of February, 1937, to approve the said Report:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme (a copy whereof is hereunto annexed) and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the Diocese of London.

#### SCHEME referred to in the foregoing Order.

We, the Ecclesiastical Commissioners for England, in pursuance of the Union of Benefices Acts, 1860 and 1898, namely, the Act of the 23rd and 24th years of Her late Majesty Queen Victoria, Chapter 142, and the Act of the 61st and 62nd years of Her said late Majesty, Chapter 23, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting an union of two contiguous Benefices within the Metropolis and within the City and Diocese of London, namely, the Benefice (being a Rectory) of Saint Edmund the King with Saint Nicholas Acons, and the Benefice (being a United Rectory) of All Hallows, Lombard Street, with
