DRESSMAKING AND WOMEN'S LIGHT CLOTHING TRADE BOARD (ENGLAND AND WALES).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made by the Minister of Labour under section 18 of the Trade Boards Act, 1909, and dated 21st April, 1927, the Dressmaking and Women's Light Clothing Trade Board (England and Wales) hereby give notice that they propose to vary minimum rates of wages for male and female workers at present set out in their Notices W.D. (25) and W.D. (26) both dated 25th May, 1934.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board at the address given below.

In accordance with section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any objections to the proposed variations which may be lodged with them within two months from 21st May, 1937. Any such objection should be in writing and signed by the person making the same (adding his or her name and address), and should be sent to the Secretary, Dressmaking and Women's Light Clothing Trade Board (England and Wales), Metropole Buildings, Northumberland Avenue, London, W.C.2. It is desirable that objections should state precisely and, so far as possible, with reasons, what is objected to.
