## SCHEDULE.

The Lancashire and Cheshire District (Coal Mines) Scheme, 1930, shall be amended in the following manner:—

1. Clause 63 shall have effect as if there were added at the end thereof the following sub-

clauses, that is to say:-

"(9) As part of the remuneration of any of their officers and servants the Board shall have power to establish a Staff Pension Fund for their benefit and may out of the District Fund make any payments due from the Board to such Staff Pension Fund.

(10) The scheme for such Staff Pension Fund may provide that the Board may enter into agreements with the trustees of any Staff Pension Fund in operation at the coal mine of any Owner or with any Owner who desires to establish a Staff Pension Fund with regard to the payments to be made into or out of the Staff Pension Fund established by the Board in respect of any officers and servants who shall be taken over or employed by the Board or who shall leave the employment of the Board and for the benefits to be received out of such Fund by any such person."

2. The First Schedule shall have effect as if—

(a) sub-clauses 4, 5 and 6 were renum-

bered 5, 6 and 7 respectively; and
(b) after sub-clause 3 thereof there were inserted the following sub-clause, that is to

say:—

"4. If the Board shall at any time after the said date establish a Staff Pension Fund the Board shall be entitled to terminate any payment made by them under sub-clause 3 of this Schedule and to enrol the sales employee in the Staff Pension Fund of the Board."
