The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS RESPECTING OPEN COMPETITIVE EXAMINATIONS FOR THE SITUATION OF FEMALE SORTING CLERK AND TELEGRAPHIST IN BELFAST, EDINBURGH, AND CERTAIN PROVINCIAL TOWNS IN GREAT BRITAIN IN THE DEPARTMENT OF THE POSTMASTER-GENERAL.

*These Regulations are liable to alteration from time to time.*

1. The limits of age for this situation are 16 and 18. Candidates must be within the prescribed limits of age on the day of the examination.

2. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject.

Provided that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all
