ELECTRICITY (SUPPLY) ACTS, 1882 TO 1936.

COUNTY OF LONDON ELECTRIC SUPPLY COMPANY (SURREY) SPECIAL ORDER, 1937.

NOTICE is hereby given that the Electricity Commissioners have submitted to the Minister of Transport for confirmation under the above-mentioned Acts a Special Order made by them on the application of the County of London Electric Supply Company Limited to authorise:—

(a) a suspension of the powers of the various local authorities to purchase the Company's undertaking under the Croydon Rural Electric Lighting Order, 1905, until the year 1972;

(b) the transfer to the Corporation of Croydon of the portion of the Company's undertaking under the Croydon Rural Electric Lighting Order, 1905, situate within the part of the County Borough of Croydon which formerly comprised the Parish of Addington; and

(c) the application to the area of a detailed scale of charges which might be reviewed by a Committee representative of the local authorities.

The Minister of Transport proposes to confirm the Order and gives notice that any person affected who may be desirous of objecting to the confirmation of the same must in accordance with the Electricity (Confirmation of Special Orders) Rules, 1931, do so by memorial addressed to the Minister of Transport written on one side only of foolscap paper and sent by registered post addressed to The Secretary, Ministry of Transport, Metropole Buildings, Northumberland Avenue, London, W.C.2, and posted not later than the 16th August, 1937. A copy of any such memorial must also be sent in like manner to the Solicitor, County of London Electric Supply Company, Limited, County House, 46-47, New Broad Street, London, E.C.2.
