

Your Majesty in Council the following Scheme relating to the United Benefice of Flixborough with Burton upon Stather, in the County of Lincoln and in the Diocese of Lincoln:

"Whereas the annual value of the said United Benefice of Flixborough with Burton upon Stather has been improved under and by virtue of a lease (hereinafter called 'the original lease') dated the 7th day of February, 1907, and granted under the authority of the said Acts by a former Incumbent of the said United Benefice of the ironstone and sand under the glebe lands belonging to such Benefice and of a further lease (hereinafter called 'the new lease') dated the 21st day of July, 1937, and granted under the same authority by the present Incumbent of the said United Benefice in renewal of the said original lease:

"And whereas by an Order of His late Majesty King George the Fifth in Council dated the 14th day of July, 1921, and published in the London Gazette on the 22nd day of the same month a portion of the improved income resulting from the said original lease, which portion included the rents and royalties thereafter payable under such lease, was appropriated to our Common Fund:

"And whereas the rents and royalties payable under the said new lease represent a further improvement of the income of the United Benefice which is at present considerably in excess of £600 per annum:

"And whereas the Reverend Edward Melvil Hadley, the present Incumbent of the said United Benefice of Flixborough with Burton upon Stather, is consenting to this Scheme in so far as his rights as Incumbent are affected thereby, and has signified such consent by signing and sealing this Scheme:

"Now, therefore, we, the said Ecclesiastical Commissioners, humbly recommend and propose that as from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme all the rents and royalties payable to us under the said new lease which shall thereafter become due and be received by us under and by virtue of the said new lease or of any renewal or renewals thereof or of any lease or leases which may hereafter be granted of the minerals included in the said new lease or any part or parts thereof shall cease to be received by us for the benefit of the Incumbent of the said United Benefice of Flixborough with Burton upon Stather and shall be received by us for the benefit of our Common Fund to be applied as in the said Acts mentioned.

"And we further recommend and propose that nothing herein contained shall prevent us from making any other recommendations and proposals relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or Measure or of any of them or of any other Act of Parliament or of any other Measure of the National Assembly of the Church of England."

And whereas the Notice of the foregoing Scheme which is required by the hereinbefore mentioned Acts, has been given by the said Commissioners to the Patron of the said United Benefice of Flixborough with Burton upon Stather and such Patron has raised no objection to the said Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lincoln.

WHEREAS the Minister of Health, after giving 10 days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to His Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the County Borough of Dudley, save with the previous approval of the Minister of Health, should be prohibited, and that burials should be discontinued therein as hereinafter directed:

And whereas by an Order in Council of the 8th June, 1937, Notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 23rd day of July next, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the said Act:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, as it is hereby ordered, that no new burial ground shall be opened in the said County Borough of Dudley save with the previous approval of the Minister of Health, and that burials shall be discontinued therein as follows, viz.:—

DUDLEY.—Forthwith and entirely in the Queen's Cross Burial Ground.
