TOWN PLANNING SCHEME NO. 5.

TOWN AND COUNTRY PLANNING ACT, 1932.

NOTICE is hereby given that (1) on the 18th day of August, 1937, the Minister of Health notified his approval of the resolution of the Urban District Council of Enfield dated the 25th day of May, 1937, deciding to prepare the above planning scheme with reference to an area situate wholly within the Urban District of Enfield; (2) a certified copy of the Map defining the area to which the resolution applies has been deposited at the office of the Council's Engineer and Surveyor at 7, Little Park Gardens, Enfield, and will be open for inspection by all persons interested without charge between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays, inclusive, and 9 a.m. to 12.30 p.m. on Saturdays; (3) any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the Urban District of Enfield and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Urban District Council of Enfield to register without charge his or their name and address for the service of subsequent notices relating to the scheme.
