Notice is hereby given that the Minister of Agriculture and Fisheries has made Orders under the Land Drainage Act, 1930, confirming the schemes submitted to him by the River Great Ouse Catchment Board under Section 4 (1) (b) of that Act, making provision for the following matters namely:—

The constitution of the Glassmoor and Mereside and the Whittlesey and Farcet Internal Drainage Districts.

The alteration of the boundaries of the Whittlesey Fifth District and of the Yaxley First Fen Drainage District.

The abolition of the following drainage districts and of the drainage boards thereof:—

Farcet Fen Drainage District;
New Farcet Fen Drainage District;
Whittlesey First Drainage District;
Whittlesey Second Drainage District;

and for certain matters supplemental thereto; and that each of the Orders will become final and have effect as an Act of Parliament unless within thirty-one days from the date of this Notice a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial, praying that the Order in respect of which the memorial is presented shall not become law without confirmation by Parliament.

ORDER OF THE REGISTRAR-GENERAL
IN ENGLAND.

(Dated 10th September, 1937.)

Whereas the Superintendent Registrar's district of Devon Central is now entirely situate in the Administrative County of Devon and the Superintendent Registrar's district of Exeter is now co-extensive with the County Borough of Exeter;

And whereas the boundaries of the Administrative County of Devon and of the County Borough of Exeter will on the 1st day of October, 1937, by virtue of the provisions of the County of Devon and County Borough of Exeter (Alteration of Boundaries) Order, 1937, be altered in such a way that the County Borough of Exeter will extend into the Superintendent Registrar's district of Devon Central;

And whereas it is expedient that the aforesaid Superintendent Registrar's district of Devon Central should continue to be entirely situate in the Administrative County of Devon and the aforesaid Superintendent Registrar's district of Exeter should continue to be co-extensive with the County Borough of Exeter;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

1.—(1) This Order may be cited as the Devon and County Borough of Exeter Registration of Births, etc., Order, 1937, and shall come into operation on the 1st day of October, 1937.
