#### NATIONAL HEALTH INSURANCE ACT, 1936.

#### RULES PUBLICATION ACT, 1893.

##### IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiration of at least 40 days from this date in pursuance of the powers conferred upon him by Section 10 of the London Traffic Act, 1924, to make the London Traffic (Prescribed Routes) (No. ) (Woodside Road, Sidcup) Regulations, 1937, in regard to a scheme of "one-way" traffic working in Woodside Road, between Main Road (A.211) and Shirley Road, Sidcup, Kent.

##### DISEASES OF ANIMALS ACTS, 1894 TO 1935.

Notice is hereby given, in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Order:—

##### FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1937 (No. 22).

###### SUBJECT.

(i) Contracts the North Riding of Yorkshire Foot-and-Mouth Disease Infected Area, as from the 27th September, 1937, to the Area as described in the First Schedule.

(ii) Releases the North Riding of Yorkshire Foot-and-Mouth Disease Infected Area from restrictions and revokes Order No. 5516, as from the 4th October, 1937.

#### FIRST SCHEDULE.

##### Contracted Infected Area.

An Area comprising:—

*In the county of the North Riding of Yorkshire.*

The borough of Richmond.

The parishes of Aske, Easby, St. Martin, Hudswell, Hipswell, Scotton, Marske, Kirby Hill, Marrick, Grinton, Downholme, Ellerton Abbey, Stainton, Walburn, Barden, East Hauxwell, West Hauxwell and Bellerby; so much of the parishes of Gilling, Whashton, Ravensworth Gayles and Dalton as lies to the west and south of the following boundary, namely: commencing at the point where the Gilling-Richmond road crosses the Gilling-Aske parish boundary, thence following the said road in a northerly direction via Gilling Church to its junction with the Ravensworth road, thence in a north-westerly direction along the road via Hartforth Hall and Hartforth Grange to its junction with the Ravensworth-Whashton road, thence along the road to Ravensworth, thence in a south-westerly, westerly and northerly direction along the road via Gayles to Dalton Church as far as the point where it crosses Dalton Beck, thence in a westerly direction along Dalton Beck to its junction with Dalton Gill, thence along Dalton Gill via Dousgill to the point where it meets the parish boundary near Low House; so much of the parish of New Forest as lies to the east of Arndale Beck; so much of the parish of Reeth as lies to the north-east and south-east of the following boundary, namely: commencing at the point where the Langthwaite-Reeth road crosses the parish boundary at Arkle Town, thence following the road in a south-easterly direction via Watson House to Reeth, thence in a westerly direction along the road from Reeth to Healaugh to the point where it touches the Reeth-Grinton-Melbecke parish boundary; and so much of the parishes of Leyburn and Preston-under-Scar as lies to the north of the road running from Redmire via Preston Pasture, Gillfield Wood and Leyburn Moor to Walburn.
