## ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 16th September, 1937.) No. 12/1937.

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar-General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:-

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in the exercise of the powers conferred by the Births and Deaths Registration Acts, 1836-1929, and with the sanction of the Minister of Health, hereby orders as follows:

(1) This Order may be cited as the Bridgend Registration of Births, etc. (alteration of Sub-districts) Order, 1937, and shall come into operation on the first day of October, 1937.

(2) The Civil Parishes of St. Brides Major and Wick now in the Cowbridge Sub-district of Bridgend Registration District, shall cease to form part of that Sub-district and shall be added to and form part of the Bridgend Subdistrict of the same Registration District.

(3) The Registrar of the existing Bridgend Sub-district shall be the Registrar of that Subdistrict as extended by this Order.
