Civil Service Commission, October 1, 1937.

The Civil Service Commissioners hereby give notice that a competitive Examination among Members of the Minor and Manipulative Grades of the Civil Service for appointment to the Clerical Classes (General and Departmental) of the Civil Service will be held, commencing on the 15th February, 1938, under the Regulations dated the 1st June, 1937, and published in the London Gazette of the same date.

The following is a provisional list of the centres at which the examination may be held:—Aberdeen, Belfast, Birmingham, Bristol, Cardiff, Darlington, Edinburgh, Exeter, Glasgow, Hull, Leeds, Liverpool, London, Manchester, Newcastle-on-Tyne, Norwich, Nottingham, Plymouth, Portsmouth, Preston, Sheffield, Stoke-on-Trent and Swansea.

The final list of centres will be decided when the number of candidates desiring examination at each centre is known.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 9th December, 1937, an application, in the candidate's own handwriting, on the prescribed form, which may be obtained from the Secretary at once.

WIDOWS', ORPHANS' AND OLD AGE CONTRIBUTORY PENSIONS ACT, 1936.

ROAD TRAFFIC ACT, 1934 (SECTION 1).

SPEED LIMITS IN THE LONDON TRAFFIC AREA.

Notice is hereby given that the Minister of Transport under and by virtue of the provisions of paragraph (b) of Sub-section (4) of Section 1 of the Road Traffic Act, 1934, intends to make the London Traffic (Built-up Areas) (No.) Order, 1937, the effect of which will be:—

(a) that there will be no speed limit under that Section in respect of any length of road specified in the First Schedule hereto; and

(b) that the speed limit under the said Section will apply throughout the length of road specified in the Second Schedule hereto.

FIRST SCHEDULE.

Noak Hill Road, Romford, Essex, between Straight Road, Broxhill Common, and the South Weald Road, Noak Hill.

Wanstead-Chipping Ongar Road (A. 113) Chipping Ongar, Essex, between Station Road and Epping-Chelmsford Road (A. 122).

SECOND SCHEDULE.

Chipping Ongar-Great Dunmow Road (B. 184), Chipping Ongar, Essex, between Epping-Chelmsford Road (A. 122) and a point 550 yards northwards thereof.
