PUBLIC HEALTH ACT, 1925.

WATERCOURSES, STREAMS, ETC.

BY an order dated 20th September, 1937, the Minister of Health has declared that the following provisions of the Public Health Act, 1925, shall be in force in certain contributory places within the Eton Rural District, namely:—

(a) In the contributory places of Burnham and Datchet:—

Section 53.

(b) In the contributory places of Dorney, Horton and Wraysbury:—

Sections 53, 54 and 55.

The above provisions are declared to be in force subject, as regards Sections 53 and 54, to the conditions specified in the order.

SPALDING GAS.

Application for Special Order under the Gas Undertakings Acts 1920 to 1934.

NOTICE is hereby given that application is intended to be made to the Board of Trade by the Urban District Council of Spalding (hereinafter called "the Council") whose address is the Council Offices, Spalding for a Special Order under the Gas Undertakings Acts 1920 to 1934 for the following or some of the following, amongst other purposes (that is to say):—

I. To authorise the transfer to and vesting in the Council of the undertaking carried on by the Holbeach Gas and Coke Company Limited (hereinafter called "the Company") upon and subject to such terms and for such consideration as have been agreed upon or as may be specified in the Order and (if deemed expedient) to confirm any agreement entered into between the Council and the Company relating to such vesting and transfer and the payment of compensation for loss of office to directors and officers of the Company.

2. To extend the limits within which the Council are authorised to supply gas (hereinafter called "the existing limits") so as to include in addition to the existing limits the parishes of Holbeach, Fleet, Gedney and Whaplode in the Rural District of East Elloe in the County of Lincoln (Parts of Holland) (hereinafter referred to as "the added limits") and to empower the Council within the added limits to exercise all the like powers in relation to the supply of gas as they now have within the existing limits and to enable the Council to maintain and use any pipes of the Company within the added limits as though they had been constructed under the authority of the Order.

3. To authorise the Council to make differential charges for gas supplied within the added limits and to enact temporary provisions in regard to the method of charge for and as to the price of gas supplied by the Council from the gasworks of the Company.

4. To authorise the Council to hold and use for the purposes of their undertaking the lands hereinafter described and thereon to continue maintain erect alter improve renew or discontinue the existing gas works of the Company and to make and store gas and residual and manufactured products and to deal in such products.

The said lands are:—

For the manufacture and storage of gas.

(1) All that piece of land situate in the parish of Holbeach in the rural district of East Elloe in the county of Lincoln containing 2 roods 2 perches or thereabouts now in the possession of the Company on which a dwelling house and out offices, retort house, gas holder (now disused) oxide shed, stores and other buildings have been erected, and which piece of land is bounded on the west by the Boston Road and is Nod. 1862 on the $\frac{25}{2508}$ ordnance map Lincolnshire (Parts of Holland) sheet CXXXV.10 Edition of 1931.

For the storage of gas.

(2) All that small plot of land situate in the said parish of Holbeach containing 734 square yards or thereabouts now in the possession of the Company with the gas holder erected thereon forming part of the enclosure Nod. 1822A on the said ordnance map, bounded on the west by the Boston Road on the north by property belonging or reputed to belong to Anthony Brocklehurst and on the east by land now or lately belonging to James Bett.

5. To confer further powers upon the Council in connection with their gas undertaking including particularly provisions empowering the Council to open and break up streets forming the boundary of their limits for the supply of gas for the purpose of supplying gas to owners or occupiers of premises within those limits abutting on such streets; for preventing improper use of gas, the position of meters, the service of gas demand notes and the recovery of charges in respect of fittings and apparatus summarily and the authentication and service of notices by the Council.

6. To authorise the Council to borrow money for the payment of any sums payable to the Company in respect of the vesting and transfer
