PLANNING SCHEME No. 2.

NOTICE is hereby given that:—1. On the twenty-eighth day of September 1937, the Minister of Health notified his approval of the resolution of the Rural District Council of St. Germans dated the first day of July 1937, deciding to prepare the above Planning Scheme with reference to an area situate wholly within the Rural District of St. Germans. 2. A certified copy of the Map defining the area to which the resolution applies has been deposited at the offices of the Markets Inspector, Callington, in the Parish of Callington, and will be open for inspection by all persons interested, without charge, between the hours of 10 a.m. and 5 p.m. on weekdays other than Saturdays, and 10 a.m. and 12 noon on Saturdays. The Map

has been deposited at the offices of the Council at the address below and may be inspected there within the same hours. 3. Any person who is, or claims to be an owner of any property in the area and any association representing owners of property within the Rural District of St. Germans and any local association representing business or industry may, by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Rural District Council of St. Germans to register without charge his or her name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933,\* the development of land in the area during the preparation of the scheme is permitted to the extent specified in the Order, and in addition, the Rural District Council of St. Germans are empowered to permit other development in the area during this period with a view in either case to protecting the development from the risk of removal or alteration without compensation under the Scheme when approved and in operation.

A print of the Order has been deposited together with the aforesaid Map.
