FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1937 (No. 23).

SUBJECT.

Declares the Area described in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

SCHEDULE.

An Area comprising:—

In the county of Kent.

The boroughs of Lydd and Tenterden.

The detached part of the petty sessional division of Liberty of Romney Marsh.

The parishes of Wittersham, Stone cum Ebony, Appledore, Snargate, Brookland, Ivychurch, Old Romney, so much of the parish of Brenzett as lies within the petty sessional division of Ashford, Benenden, Rolvenden, Newenden, Sandhurst, Hawkhurst, and so much of the parish of Woodchurch as lies to the south of the road running from Appledore Heath via Walter House, Brook Street, and Pearce Barn to Tenterden.

In the county of East Sussex.

The county borough of Hastings.
The boroughs of Bexhill and Rye.

An Area comprising:—

In the county of Lincoln (parts of Lindsey).

The borough of Louth.

The petty sessional divisions of Louth, Alford (*except the parishes of Anderby, Mumby, Chapel St. Leonards and Hogsthorpe*), Spilsby (*except the parishes of Addelethorpe, Ingoldmells, Skegness, Orby, Burgh le Marsh, Croft, Wainfleet St. Mary, Wainfleet All Saints, Friskney, so much of the parish of Thorpe St. Peter as lies to the east of the London and North Eastern Railway line running from Wainfleet All Saints to Firsby, Sibsey, Frithville, and so much of the parishes of Westville and Carrington as lies to the south of the road running from Northlands via Hakerley Bridge and Shorts Corner to Bunkers Hill*), Horncastle (*except the parishes of Wildmore, Thornton le Fen and Langrville*), Wragby and Market Rasen (*except the parishes of Owersby and so much of the parish of Osgodby as comprises the former parish of Kingerby*).
