DISEASES OF FISH.

The Diseases of Fish (Delegation of Powers) Order, 1937, dated the 20th October, 1937, made by the Secretary of State in pursuance of Section II (d) of the Diseases of Fish Act, 1937.

I. In pursuance of the power conferred upon him by Section II (d) of the Diseases of Fish Act, 1937, the Secretary of State hereby delegates to the Fishery Board for Scotland all the powers exercisable by him under that Act, with the exception of the power to make regulations in terms of Section 9 and the power conferred by Section I (3) (c) to determine, with the consent of the Treasury, the fee to be paid on the grant of a licence under the Act.
