FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1937 (No. 33).

SUBJECT.

Declares the Area described in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

SCHEDULE.

An Area comprising:—

*In the county of Norfolk.*

The borough of Thetford.

The petty sessional divisions of Grimshoe, Clackclose, South Greenhoe (*except the parishes of South Acre, Sporle with Palgrave, Necton, West Bradenham, East Bradenham, Holme Hale and Newton by Castle Acre*) and so much of the Petty Sessional Division of Freebridge Marshland as lies to the south of the railway line running from Magdalen Road Station via Middle Drove Station to Wisbech, and to the east of the Middle Level Main Drain.

The parishes of Pentney, Little Cressingham, Tottington, Merton, Thompson, Hockham, Wretham, Croxton, Kilverstone, Brettenham, Bridgham, Roudham, and so much of the parishes of Stow Bedon, Griston, Watton, Ovington, Saham Toney and Ashill as lies to the west of the railway running from Holme Hale Station to Wretham and Hockham Station.

*In the county of West Suffolk.*

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1937 (No. 32).

SUBJECT.

Declares the Area described in the Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

SCHEDULE.

An Area comprising:—

*In the county of Kent.*

The city and county borough of Canterbury.

The boroughs of Folkestone, Hythe, Dover, Faversham, Deal, Ramsgate, Margate and Sandwich.

The petty sessional divisions of Thanet (including its detached part), St. Augustine, Faversham, Wingham, Ramsgate, Elham (including its detached parts), Liberty of Romney Marsh (including its detached part), and so much of the petty sessional division of Ashford (including its detached part) *but excluding the road* as lies to the north of the road running from Tenterden via Leigh Green, Reading Street, Appledore Church, Appledore Station, Snargate, Brenzett and Old Romney to New Romney.

The parishes of Ringwould, Sittingbourne and Milton, Bobbing, Borden, Tunstall Bapchild, Tonge, Rodmersham, Kingsdown, Milstead, Bredgar, Bicknor, Wormshill, Frinsted, Hollingbourne, Harrietsham, Lenham, Wichling, Ulcombe, Otterden, Boughton Malherbe, Broomfield, High Halden, Sarre, so much of the parish of Headcorn as lies to the east of the road running from Maidstone via Langley, Headcorn Church and Biddenden to Tenterden.

*The Lee Conservancy Catchment Area.*
