LAND DRAINAGE ACT, 1930.

River Great Ouse Catchment Board.

*March and Whittlesey Internal Drainage
District.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a scheme submitted to him by the River Great Ouse Catchment Board under Section 4 (1) (b) of that Act, making provision for the abolition of the March Fourth and the Whittlesey Fourth Drainage Districts and of the Drainage Boards thereof; the constitution of the March and Whittlesey Internal Drainage District and of a drainage board therefor, and for certain matters supplemental thereto, and that the Order will become final and have effect as an Act of Parliament unless within thirty-one days from the date of this Notice a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial, praying that the Order shall not become law without confirmation by Parliament.

A copy of the sealed Order has been deposited, together with a copy of the Scheme, as amended, and of the map referred to therein, at the Middle Level Offices, March, Cambridgeshire, for public inspection for a period of thirty-one days from the date of this Notice, and may be inspected during the ordinary hours of business. A further copy of each document has been deposited for a like period at the Offices of the River Great Ouse Catchment Board, Elmhurst, Brooklands Avenue, Cambridge, and may be similarly inspected.
