**SUBJECT.**

(i) Contracts, as from the 20th November, 1937, the Essex Foot-and-Mouth Disease Infected Area to the Area described in the First Schedule.

(ii) Releases the Essex Foot-and-Mouth Disease Infected Area from restrictions and revokes Order No. 5536 as from the 27th November, 1937.

**FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1937 (No. 43).**

**SUBJECT.**

(i) Declares the Area described in the First Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

(ii) Provides that the Area described in the Second Schedule, which is included in the Infected Area declared by this Order, shall

cease to form part of the Foot-and-Mouth Disease Infected Area to which the Foot-and-Mouth Disease (Infected Areas) Order of 1937 (No. 35) applies and that the Foot-and-Mouth Disease (Infected Areas) Order of 1937 (No. 42) shall be read and have effect accordingly.

**FIRST SCHEDULE.**

An Area comprising:—

*In the county of Essex.*

The boroughs of Ilford, Leyton, Walthamstow, Romford, Wanstead and Woodford, and so much of the borough of Barking as lies to the north of the London Midland and Scottish Railway line running from Wood Grange Park Station to Dagenham.

The Petty Sessional Divisions of Epping, Harlow and Ongar.

The parishes of Little Easton, Little Canfield, Great Dunmow, Little Dunmow, Barnston, Birchanger, Stansted Mountfitchet, Elsenham, Farnham, Manuden, Takeley, Great Canfield, High Roding, Aythorpe Roding, White Roding, Leaden Roding, Margaret Roding, High Easter, Good Easter, Roxwell, Writtle, Doddinghurst, Noak Hill, Havering Atte Bower, Romford; so much of the parishes of Dagenham, Hornchurch and Upminster, as lies to the north of the London Midland and Scottish Railway line running from Barking to East Horndon Station; and so much of the parishes of Brentwood, Mountnessing, Ingatestone and Fryerning, and Margaretting as lies to the north and north-west of the London and North Eastern Railway line running from Romford to Chelmsford.
