

not less than three members of the Governing Body (of whom the Vice-Principal may be one) and shall be held not less than six months before the date on which the retirement of the Principal would take place under the provisions of this Clause.

Any such meeting may be adjourned by resolution of the meeting to a date to be specified in the resolution, provided that such date shall not be less than six months before the date on which the Principal would retire under the provisions of this Clause.

*Retirement by resignation:—*

The Principal may resign his office at any time on giving to the Governing Body such notice of his intention to resign as the Governing Body shall deem reasonable.

*Pension on retirement:—*

The Principal on retirement shall receive such pension as shall be assigned to him under Statute XVII.

UNIVERSITY OF OXFORD.

STATUTE APPROVED BY CONGREGATION ON TUESDAY, 23 NOVEMBER, 1937.

WHEREAS it is expedient to remove anomalies and obsolete provisions from the Statutes of the University of Oxford:

Now the said University, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, enacts, subject to the approval of His Majesty in Council, as follows:—
