

10. Application for permission to attend an examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.

11. A fee of £1 will be required from every candidate attending an Examination.

The Civil Service Commissioners further give notice that a Competitive Examination will be held under the foregoing Regulations on the 26th April, 1938.

The following is a provisional list of the centres at which the examination may be held:—Aberdeen, Belfast, Birmingham, Bristol, Cardiff, Chester, Darlington, Edinburgh, Exeter, Glasgow, Hull, Leeds, Liverpool, London, Manchester, Newcastle-on-Tyne, Norwich, Nottingham, Plymouth, Portsmouth, Preston, Salisbury, Sheffield, Stoke-on-Trent, Swansea and York.
