The county borough of Southampton.  
The boroughs of Gosport, Romsey and Eastleigh.

The petty sessional divisions of Hythe, Fareham, Havant, Droxford, Eastleigh (including its detached part), Winchester (except the parishes of Ashley, Crawley, Little Somborne, Wonston, Micheldever; so much of the parish of Kings Somborne as lies within the said petty sessional division; and so much of the parish of Sparsholt as lies to the north of the road running from Littleton via Lainston House and Sparsholt Church to Kings Somborne and except the said road), Alresford (except the parish of Candovers) and Petersfield (except its detached part and the parishes of Hawkey, Greatham and Liss).
