Order No. 5651.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 41).

SUBJECT.

Declares the Area described in the First Schedule to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925 and includes in such area parts of the Dorset, Wilts, etc., and Hampshire Infected Areas as described in the Second and Third Schedules respectively.

FIRST SCHEDULE.

IN THE COUNTY OF SOUTHAMPTON.

The county borough of Bournemouth.

The boroughs of Christchurch and Lymington.

The petty sessional divisions of Christchurch, Ringwood, Lymington, New Forest (except the parish of Eling) and Fordingbridge (except the parish of Martin).

In the petty sessional division of Hythe.

The parishes of Beaulieu and Exbury.

IN THE COUNTY OF WILTSHIRE.

In the petty sessional division of Salisbury and Amesbury.

The parishes of Redlynch and Downton (except the former parish of Standlynch with Charlton All Saints).

IN THE COUNTY OF DORSET.

The boroughs of Poole and Wareham.

The petty sessional division of Wimborne (except the parishes of Pentridge, Handley, Gussage Saint Michael, Long Crichel, Tarrant Rushton and Tarrant Crawford, and so much of the parish of Sturminster Marshall as lies to the west of the road running from Tarrant Crawford via Crawford Bridge to Almer and except the said road).

In the petty sessional division of Wareham.

The parishes of Studland and Swanage; so much of the parish of Wareham St. Martin as lies to the east of the road running from Morden via Sherford Bridge and Potter Works to Wareham; and so much of the parishes of Arne, Corfe Castle, Worth Matravers, and Langton Matravers, as lies to the north-east of the road running from Wareham via Stoborough Heath, Norden Farm, Corfe Castle Station, Town's End, Harman's Cross Roads and Langton Matravers to Swanage.

SECOND SCHEDULE.

The parishes of Verwood, Alderholt, Horton, Chalbury, More Crichel, Woodlands, Gussage All Saints, Wimborne St. Giles, Edmondsham and Cranborne.

IN THE COUNTY OF SOUTHAMPTON.

The petty sessional division of Fordingbridge (except the parish of Martin).

The parishes of Bramshaw and Harbridge and Ibsley; so much of the parishes of Copythorne, Minstead, Ellingham, Burley, Ringwood and St. Leonards and St. Ives as lies to the north-west and north of the following boundary, namely:—the main road running from Romsey via Blackwater Bridge, Cadnam, Castle Malwood, Stoney Cross and Picket Post to Ringwood and thence along the road from Ringwood via Ashley and Wools Bridge to Horton.

IN THE COUNTY OF WILTSHIRE.

The parishes of Redlynch and Downton (except the former parish of Standlynch with Charlton All Saints).

The boroughs of Folkestone, Hythe, Lydd, New Romney and Tenterden

The petty sessional divisions of Elham, including its detached parts, Liberty of Romney Marsh. including its detached part, Ashford, including its detached part (except the parishes of Smarden, Egerton, Charing, Molash and Chilham; and so much of the parishes of Westwell and Challock as lies to the north of the road running from Charing via Paddock and Challock Lees to Molash and except the said road).
