RULES PUBLICATION ACT, 1893.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiration of at least 40 days from this date in pursuance of the powers conferred upon him by Section 10 of the London Traffic Act, 1924, to make Regulations in regards to the undermentioned schemes of "one-way" traffic working:—

1. At the junction of Dagenham Avenue and Hedgemans Road, Dagenham.
2. In Essenden Road between Picardy Road and Berkhamstead Road, Erith.

3. In Leapale Road and Woodbridge Road between North Street and its junction with Leapale Road, Guildford.

4. In Carnaby Street and the southern arm of Great Marlborough Street, Westminster.

The short titles of the draft Regulations are respectively:—

1. The London Traffic (Prescribed Routes) (No.) (Dagenham) Regulations, 1938.
2. The London Traffic (Prescribed Routes) (No.) (Erith) Regulations, 1938.
3. The London Traffic (Prescribed Routes) (No.) (Guildford) Regulations, 1938.
4. The London Traffic (Prescribed Routes) (No.) (Carnaby Street, Westminster) Regulations, 1938.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given that the Minister of Transport, in exercise of the powers conferred on him by Section 10 of the aforesaid London Traffic Act, has by virtue of Section 2 of the Rules Publication Act, 1893, made the London Traffic (Parking Places) (Amendment) No. 3 Provisional Regulations, 1938, to come into force forthwith as Provisional Regulations and to continue in force until Statutory Rules have been made in accordance with the last-mentioned Act.

The Regulations, which amend the London Traffic (Parking Places) Regulations, 1936, provide for the abolition of the parking place in Woodmansterne Road, Croydon.
