By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

#### ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 23rd March, 1938.)

No. 4/1938.

Whereas the boundaries of the Administrative County of York, West Riding, and of the County Borough of Sheffield will on the 1st day of April, 1938, by virtue of the provisions of the County of York, West Riding, and County Borough of Sheffield (Alteration of Boundaries) Order, 1938, be altered in such a way that the County Borough of Sheffield will extend into the Superintendent Registrars' districts of Rother Valley and Wortley and the Administrative County of York, West Riding, will extend into the Superintendent Registrar's district of Sheffield;

And whereas it is expedient that the aforesaid Superintendent Registrars' districts of Rother Valley and Wortley should each be entirely situate in the Administrative County of York, West Riding, and the aforesaid Superintendent Registrar's district of Sheffield should continue to be co-extensive with the County Borough of Sheffield;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England, in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

1.—(1) This Order may be cited as the County of York, West Riding, and County Borough of Sheffield Registration of Births, etc., Order, 1938, and shall come into operation on the 1st day of April, 1938.

(2) In this Order the term "district" means a Superintendent Registrar's district, and the terms "existing district" and "existing sub-district" mean respectively a district and a sub-district as constituted immediately before the operation of this Order.

2. That portion of the existing Rother Valley district consisting of part of the parish of Orgreave, and that portion of the existing Wortley district consisting of part of the parish of Bradfield, which will, by virtue of the County of York, West Riding, and County Borough of Sheffield (Alteration of Boundaries) Order, 1938, be included in the County Borough of Sheffield shall respectively become separate districts and shall thereupon be united with the existing Sheffield district.

3. That portion of the existing Sheffield district consisting of part of the parish of Sheffield which will by virtue of the aforesaid Order be included in the parish of Orgreave shall become a separate district and shall thereupon be united with the existing Rother Valley district.

4. That portion of the parish of Orgreave added to the Sheffield district by Article 2 of this Order shall cease to be included in the Maltby sub-district and shall be added to and form part of the Sheffield East sub-district.

5. That portion of the parish of Bradfield added to the Sheffield district by Article 2 of this Order shall cease to be included in the Ecclesfield sub-district and shall be added to and form part of the Sheffield North West sub-district.

6. That portion of the parish of Sheffield added to the Rother Valley district by Article 3 of this Order shall cease to be included in the Sheffield East sub-district and shall be added to and form part of the Maltby sub-district.

7. The Superintendent Registrars of the existing Rother Valley and Sheffield districts shall respectively be the Superintendent Registrars of those districts as altered by this Order.

8. The Registrars of Births and Deaths of the existing Maltby, Sheffield East and Sheffield North West sub-districts shall respectively be the Registrars of Births and Deaths of those sub-districts as altered by this Order.
