FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 65).

SUBJECT.

I. Contracts the Foot-and-Mouth Disease Infected Areas around Birmingham etc., and Cumnor, Berks, as from the 19th April, 1938, so as to comprise only the areas Nos. 1 and 2 described in the First Schedule.

II. Amends the Foot-and-Mouth Disease (Birmingham Pig Market) Order of 1938 so as to apply only to the area No. 1 described in the First Schedule.

III. Revokes the Orders described in the Second Schedule.
