FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 67).

SUBJECT.

I. Contracts the Foot-and-Mouth Disease Infected Area around Sheffield, as from the 22nd April, 1938, so as to comprise only the Area described in the Schedule.

II. Releases the Foot-and-Mouth Disease Infected Area around Sheffield and revokes Order No. 5704, as from the 29th April, 1938.

SCHEDULE.

*Contracted Infected Area.*

An Area comprising:—

**IN THE COUNTY OF THE WEST RIDING OF YORKSHIRE.**

The city and county borough of Sheffield.  
The county borough of Rotherham.

*In the petty sessional division of Upper Strafforth and Tickhill.*

The parishes of Brinsworth, Catcliffe, Orgreave, and Treeton; so much of the parishes of Whiston and Aston cum Aughton as lies to the west of the road running from Rotherham via Oakwood Hall, Guilthwaite, Ulley Reservoir, Aughton Hospital and Beighton Station to Beighton; and so much of the parishes of Bradfield and Ecclesfield as lies to the east and the south east of the road running from Cutthroat Bridge via Moscar Fields, Strine's Moor, Thornseat, Agden Reservoir, Bradfield Orphanage, Oughtibridge, Top End, Woodseats, Burncross and Hesley Park to Hoyland Common.

**IN THE COUNTY OF DERBY.**

*In the petty sessional division of Eckington.*

So much of the parish of Beighton as lies to the west of the road running from Aughton via Beighton Church and Waterthorpe Farm to Eckington; and so much of the parishes of Eckington and Dronfield as lies to the north of the road running from Beighton via Windmill Hill, Eckington Church, Marshlane, Moor-top Farm, Black-a-moor Head Inn, Coal Aston and Dychelane Farm to Norton Woodseats.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 68).

SUBJECT.

I. Contracts the Wiltshire Foot-and-Mouth Disease Infected Area so as to comprise only the Areas Nos. 1 and 2 described in the First Schedule, and revokes the Orders described in the Second Schedule as from the 24th April, 1938.

II. Releases Area No. 1 described in the First Schedule from restrictions as from the 27th April, 1938.

III. Releases Area No. 2 described in the First Schedule from restrictions as from the 1st May, 1938.

FIRST SCHEDULE.

AREA No. 1.

*Area around Pewsey, Wilts.*

An Area comprising:—

**IN THE COUNTY OF WILTSHIRE.**

*In the petty sessional division of Everley and Pewsey.*

The parishes of Alton, Woodborough, Huish, Wilcot, Pewsey, Milton Lilbourne, Wootton Rivers, Easton, Manningford, North Newton and Everleigh; so much of the parishes of Collingbourne Kingston and Collingbourne Ducis as lies to the west of the railway line running from Grafton and Burbage Station to Ludgershall; and so much of the parishes of Enford, Upavon, Rushall, Charlton and Wilsford as lies to the east and north of the road running from Netheravon, via Enford, West Chisenbury, Rushall, and Coombe to Urchfont.

*In the petty sessional division of Devizes.*

The parishes of Beechingstoke and Stanton St. Bernard.

*In the petty sessional division of Marlborough and Hungerford.*

The parishes of East Kennett, Burbage and Savernake; and so much of the parishes of West Overton, Fyfield and Preshute as lies to the south of the River Kennet.

AREA No. 2.

*Area around Calne, Wilts.*

An Area comprising:—

**IN THE COUNTY OF WILTSHIRE.**

The boroughs of Calne and Chippenham.  
The petty sessional division of Calne.

*In the petty sessional division of Cricklade.*

The parish of Lyneham.

*In the petty sessional division of Chippenham.*

The parishes of Pewsham and Langley Burrell Without; so much of the parish of Lacock as lies to the east of the Great Western Railway line running from Chippenham to Staverton; and so much of the parishes of Sutton Benger and Christian Malford as lies to the south east of the road running from Kington Langley via Sutton Benger Church, Beanhill Farm and Swallet Gate to Dauntsey Green.

*In the petty sessional division of Melksham.*

So much of the parish of Melksham Without as lies to the east of the Great Western Railway line running from Chippenham to Trowbridge and north of the road running from Melksham via Blackmore Forest and Sandridge Park to Bromham.

*In the petty sessional division of Devizes.*

The parishes of Rowde and Bromham; and so much of the parishes of Roundway and Bishop's Cannings as lies to the north and north
