**FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1938 (No. 75).**

**SUBJECT.**

I. Contracts the Foot-and-Mouth Disease Infected Area around Oxford, as from the 11th May, 1938, so as to comprise only the Area described in the Schedule.
