North-East Cheshire Rivers Catchment Board.

(a) confirming the Order made on the 14th April, 1938, in relation to the Scheme prepared by the North-East Cheshire Rivers Catchment Board, under Section 4 (1) (b) of the Act, making provision for the abolition of the Sinderland and Baguley Drainage District so far as it is situate within the Catchment Area and for the abrogation of the powers of the Drainage Board thereof so far as such powers are exercisable in any part of the Catchment Area; and

(b) under Section 4 (1) (a) of the Act, confirming the Scheme for the transfer to the North-East Cheshire Rivers Catchment Board of all such rights, powers, duties, obligations and liabilities (including liabilities incurred in connection with works) over or in connection with the main river as were immediately before the commencement of the said Act vested in or to be discharged by the Sinderland and Baguley Drainage Board, or any other drainage authority, and of any property held by the said Board or by any other drainage authority for the purpose of or in connection with, any functions so to be transferred.

duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
