

MILK ACTS, 1934 TO 1937.

Notice is hereby given that the Minister of Agriculture and Fisheries and the Secretary of State for Scotland, acting jointly, and with the approval of the Treasury, have issued the following certificate dated 4th May, 1938.

Certificate of Cheese-Milk Price and Butter-Milk Price.

In accordance with the provisions of Section 5 of the Milk (Amendment) Act, 1937, the Minister of Agriculture and Fisheries and the Secretary of State for Scotland hereby certify:—

(1) that the cheese-milk price for the month of February, 1938, was 7.37d. per gallon and that the butter-milk price for the said month was 5.18d. per gallon;

(2) that the cheese-milk price for the month of March, 1938, was 6.73d. per gallon, and that the butter-milk price for the said month was 4.88d. per gallon.
