I.—(I) This Order may be cited as the Barnsley Registration of Births, etc., Order, 1938, and shall come into operation on the 1st

day of July, 1938.

" district (2) In this Order the term means a superintendent registrar's district, and the term "existing district" means a district which existed immediately before the 1st day of July, 1938.

2.—(1) The existing Barnsley district shall be divided into two districts called respectively the Barnsley and the Staincross districts.

(2) The Barnsley district shall consist of that portion of the existing Barnsley district which is situate within the County Borough of Barnsley.

(3) The Staincross district shall consist of that portion of the existing Barnsley district which is situate within the Administrative County of York, West Riding.

3. The superintendent registrar of the exist-ing Barnsley district shall be the superintendent registrar of the Staincross district as constituted by this Order.

To alter, amend or repeal or to re-enact (with or without modification) the provisions of Section 20 (Limiting price of gas) of the Chemsford Corporation Gas Act, 1915, and Section 3 (Maximum price) of the Chelmsford Gas (Charges) Order, 1922, and in other respects to alter, amend or repeal the Chelmsford Gas Acts and Orders, 1914 to 1936.
4. To incorporate with the Order with or

without modification or to render inapplicable to the Corporation, all or some of the provisions of the Gasworks Clauses Act, 1847, and the

Gasworks Clauses Act, 1871.
5. To confer upon the Corporation other convenient or incidental powers including powers as to the payment of the costs, charges and expenses of the Order, and to vary or extinguish all rights or privileges which would impede or interfere with the purposes of the Order and to confer other rights and privileges.

Any local or other public authority, company or person desirous of bringing before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the 15th day of July, 1938.

Any such objections shall state:-

(a) The specific grounds of objection; and (b) The omissions, additions or modifications asked for.
