Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

Whereas the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 6th and 7th years of Her late Majesty, Queen Victoria, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 7th day of April, 1938, in the words and figures following, that is to say:— "We, the Ecclesiastical Commissioners for

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the New Parish (sometime Chapelry District) of Middleton (in Rothwell) and partly out of the New Parish (sometime Consolidated Chapelry) of Saint Andrew, Stourton, both in the County of York and in the Diocese of Ripon: "Whereas we are satisfied that the said

"Whereas we are satisfied that the said New Parish of Middleton (in Rothwell) and the said New Parish of Saint Andrew, Stourton, are Cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it appears to us that it would promote the interests of religion that the particular portions of the said New Parish of Middleton (in Rothwell) and of the said New Parish of Saint Andrew, Stourton, which are mentioned and described in the Schedule to this Scheme and are delineated on the map or plan annexed to this Scheme should be constituted a separate District for ecclesiastical purposes in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas by an Order of Your Majesty in Council bearing date the 13th day of April, 1937, and published in the London Gazette on the 16th day of the same month the Benefice of Christ Church, Leeds, and the Benefice of Saint John the Evangelist with Saint Barnabas, Leeds, both in the said County and Diocese, were united into one Benefice and it was by the same Order provided amongst other things (I) that out of the aggregate fund comprising the proceeds of the sale of the sites and materials of the Churches of Saint Barnabas and Saint John the Evangelist, Leeds, and of the Parsonage Houses of the said Benefices of Christ Church, Leeds, and Saint John the Evangelist and Saint Barnabas, Leeds, a Church, Parsonage House and Parish Hall should be provided for a proposed new ecclesiastical District to be formed at Belle Isle, Leeds, (2) that all the endowments belonging to the said Benefice of Saint John the Evangelist with Saint Barnabas, Leeds, should be held and accumulated for and towards the endowment of such proposed new District, and (3) that the patronage of such proposed new District should be vested in the Bishop of Ripon for the time being:

"And whereas the endowments which will be available for such proposed new District under the terms of the hereinbefore mentioned Order in Council will provide an income of not less than $\pounds 400$ per annum:

"Now, therefore, with the consent of the Right Reverend Geoffrey, Bishop of Ripon (in testimony whereof he has set his hand and Episcopal Seal to this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said New Parish of Middleton (in Rothwell) and of the said New Parish of Saint Andrew, Stourton, which are described in the Schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day upon which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette, become and be constituted a separate District for spiritual purposes by the name of 'The District of Saint John and Saint Barnabas, Belle Isle, Leeds'.

"And we further recommend and propose that the whole right of patronage of the said proposed District and, when such District shall have become a New Parish, then of such New Parish and the nomination of the Minister or Incumbent thereof shall, as provided by the said Order in Council of the 13th day of April, 1937, be vested in and exercised by the said Geoffrey, Bishop of Ripon, and his successors for ever.

"And we further recommend that nothing herein contained shall prevent us from recommending or proposing any other measures relating to the matters aforesaid or to any of them in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint John and Saint Barnabas, Belle Isle, Leeds, comprising: _____

"All those contiguous portions of the New Parish (sometime Chapelry District) of Middle ton (in Rothwell) and of the New Parish (sometime Consolidated Chapelry) of Saint Andrew, Stourton, both in the County of York and in the Diocese of Ripon, which, taken together, are bounded upon part of the north by the New Parish of Hunslet, in the said County and Diocese, and upon the remaining sides, that is to say, upon the remaining part of the north, upon the east, upon the south and upon the west, by an imaginary line commencing upon the boundary which divides the said New Parish of Hunslet from the said New Parisb
