#### RULES PUBLICATION ACT, 1893.

##### LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport after the expiry of at least forty days from this date in pursuance of the powers conferred upon him by Section 10 of the aforesaid London Traffic Act to make the London Traffic (Parking Places) (Amendment) No. 10 Regulations, 1938:—

(1) To appoint parking places in Arklow Road, Crooke Road, Dixon Road, Scawen Road and St. James's, Deptford; Royal Road, St. Albans; Manchester Street, St. Marylebone, and Oakend Way, Gerrards Cross.

(2) To curtail the limits of a parking place in Sutton Court Road, Sutton.

(3) To extend the limits of parking places in Bloomsbury Square, Holborn and Portland Place, St. Marylebone.
