PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 16th day of June, 1938 (N.3289/38), in the words following, viz.:—

“Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

“And whereas it is provided by Order in Council dated the 13th October, 1920, that an allowance of 10s. a week is to be paid to any properly qualified person discharging the duties of Organist and Choir Master in Your Majesty's Naval Training Establishment at Shotley and in Your Majesty's Ships *Impregnable*, *Fisgard* and *Indus*:

“And whereas Your Majesty's Ships *Fisgard* and *Indus* have ceased to be Training Establishments and we consider it expedient to provide for payment of the allowance in Your Majesty's Ships *Caledonia*, *St. Vincent* and *Wildfire*, or in any other Training Establishment which may be created in the future:

“We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the payment of an allowance of 10s. a week to the qualified person discharging the duties of Organist and Choir Master in any Boys' Training Establishment.

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.”

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

“Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having

been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

“And whereas, in consideration of the discomforts caused by service in Motor Torpedo Boats, authority was given by Order in Council of 8th June, 1937, for the issue to personnel of these vessels of extra pay continuously at one half of the rates laid down in the Regulations for the payment of extra pay for general work:

“And whereas the conditions under which Officers and men are called upon to serve in Motor Minesweepers are comparable to those in Motor Torpedo Boats and we are therefore of opinion that they should also receive this extra remuneration:

“We beg leave humbly to recommend that Your Majesty will be graciously pleased, by Your Order in Council, to sanction payment accordingly.

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.”

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
