his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion be expedient that all that part of the said New Parish of All Saints, Ipswich, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Thomas, Ipswich, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Thomas, Ipswich.'

"And with the like consent of the said Walter Godfrey, Bishop of Saint Edmundsbury and Ipswich (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Thomas, Ipswich, situate as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Thomas, Ipswich, being: ____

"All that part of the New Parish (sometime Consolidated Chapelry) of All Saints, Ipswich, in the County of Suffolk and in the Diocese of Saint Edmundsbury and Ipswich, which is bounded upon all sides as follows, that is to say, upon the north east by the Parish of Whitton with Thurlestone, upon the north west by the Parish of Bramford, upon the south west by the Parish of Sproughton, upon part of the south east by the Parish of Saint Mary, Stoke, all in the said County and Diocese, and upon the remaining part of the south east by an imaginary line commencing upon the boundary which divides the said Parish of Saint Mary, Stoke, from the said new Parish of All Saints, Ipswich, at the centre of the bridge which carries the East Suffolk branch line of the London and North Eastern Railway across the River Gipping, and extending thence north eastward along the middle of the said line of railway for a distance of 72 chains or thereabouts to the boundary which divides the said New Parish of All Saints, Ipswich, from the said Parish of Whitton with Thurlestone.'

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Saint Edmundsbury and Ipswich.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measures, 1923 to 1936, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 21st day of July, 1938, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the Parish of Hollym with Withernsea and of the Parish of Hollym with Withernsea and of the Parish of Holmpton, both in the County of York and in the Diocese of York:

"Whereas it has been represented to us, the said Ecclesiastical Commissioners, and it appears to us to be desirable that the boundaries of the said Parish of Hollym with Withernsea and of the said Parish of Holmpton should be altered in the manner which is hereinafter mentioned:

"And whereas the Benefice of Hollym with Withernsea and the United Benefice of Welwick with Holmpton are now full, the Reverend William Reeder being the present Incumbent of the Benefice of Hollym with Withernsea and the Reverend Albert Leslie Robins being the present Incumbent of the United Benefice of Welwick with Holmpton and such Incumbents have signified their consents to the proposals hereinafter mentioned by signing this Scheme:

"And whereas the Diocesan Committee of the said Diocese of York, appointed pursuant to the first section of the Union of Benefices Measure, 1923, have by a Resolution passed on the 16th day of April, 1938, signified their consent to the alteration of boundaries herein proposed:

"Now, therefore, with the consent of the Right Honourable and Most Reverend William, Archbishop of York (in testimony whereof he has signed this Scheme), we, the said Ecclesi-astical Commissioners for England, humbly recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any assurance in the law other than such duly gazetted Order the boundaries of the said Parish of Hollym with Withernsea and of the said Parish of Holmpton shall be altered by the transfer to the said Parish of Holmpton of all those portions of the said Parish of Hollym with Withernsea which are situate within the Civil Parish of Holmpton to the intent that the boundaries of the said Parish of Holmpton shall coincide with the present boundaries of the Civil Parish of Holmpton as shown upon the map or plan hereunto annexed.

"And we further recommend and propose that nothing herein contained shall prevent us from making any other recommendations and proposals relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measures, or of any other Measure
