after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Bristol.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94; of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94; and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared and laid before His Majesty in Council a Scheme or Representation, bearing

date the 21st day of July, 1938, in the words and figures following, that is to say:—
"We, the Ecclesiastical Commissioners for

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared and now humbly lay before Your Majesty in Council the following Scheme or Representation for altering the boundaries of the New Parish of Saint James, Enfield, of the New Parish of Saint Luke, Enfield, and of the New Parish of Saint George, Enfield, all in the County of Middlesex and in the Diocese of London:

"Whereas a District Chapelry has been assigned to the Church of Saint James, Enfield, a Chapelry District has been assigned to the Church called Jesus Chapel, Enfield, a District Chapelry has been assigned to the Church of Saint Luke, Enfield, and a Consolidated Chapelry has been assigned to the Church of Saint George, Enfield, by the Orders in Council, the dates of which are stated in the 3rd Column of the following Table:—

"And whereas the said District Chapelry of Saint James, Enfield, the said Chapelry District of Jesus Chapel, Enfield, the said District Chapelry of Saint Luke, Enfield, and the said Consolidated Chapelry of Saint George, Enfield, have become New Parishes of the character contemplated by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, by the Act of the 19th and 20th years of Her said late Majesty, Chapter said late Majesty, Chapter said late Majesty, Chapter 104, and by the abovementioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parishes should be altered in the manner which is hereinafter

mentioned:

"Now, therefore, with the consent of the Right Honourable and Right Reverend Arthur Foley, Bishop of London (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and pro-pose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Saint James, Enfield, of the said New Parish of Jesus Chapel, Enfield, of the said New Parish of Saint Luke, Enfield, and of the said New Parish of Saint George, Enfield, shall be altered so that (first) all those portions of the Parish of Enfield, in the said County and Diocese, and of the said New Parish of Jesus Chapel, Enfield, which are described in the First Schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such Parish and New Parish respectively and shall be annexed to and shall in future form part of the said New Parish of Saint James, Enfield; (secondly) all those portions of the said New Parish of Jesus Chapel, Enfield, and of the said New Parish of Saint James, Enfield, which are described in the Second Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured blue shall be dissevered from such New Parishes and shall be annexed to and shall in future form part of the said New Parish of Saint George, Enfield; (thirdly) all that portion of the said Parish of Enfield which is described in the Third Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured green shall be dissevered from such Parish and shall be annexed to and shall in future form part of the said New Parish of Jesus Chapel, Enfield, and (fourthly) all that portion of the said Parish of Enfield which is described in the Fourth Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured purple shall be dissevered from such Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Luke, Enfield.
