3. The Indian Aircraft Act, 1934, and the Indian Aircraft (Amendment) Act, 1936, and all Rules made under the said Acts and under the Indian Aircraft Act, 1911, shall, in the application of the said Acts and Rules to the Colony of Aden, be repealed.
