River Ancholme and Winterton Beck Catchment Area.

The Minister of Agriculture and Fisheries hereby gives notice that the River Ancholme and Winterton Beck Catchment Board have made application under sub-section (3) of Section 5 of the Land Drainage Act, 1930, for the variation of the statutory map of the Catchment Area, so far as relates to the extent of the "main river" as at present defined on the said map, by the addition thereto of the watercourse known as the Weir Dyke, in the Parishes of Horkstow, Roxby-cum-Risby, Saxby All Saints, Bonby, Worlaby and Broughton.

River Ouse (Yorks.) Catchment Board.

Upper and Lower Swale Internal Drainage Boards.

Notice is hereby given that the Minister of Agriculture and Fisheries has made Orders under the Land Drainage Act, 1930, confirming the Orders made on the 16th June, 1938, in relation to the Schemes prepared by the River Ouse (Yorks.) Catchment Board, under Section 4 (1) (b) of the Act, making provision for the extension of the period of office of the first members of the Upper and Lower Swale Internal Drainage Boards until the 1st day of November, 1939.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
