REGULATIONS FOR THE COMPETITIVE SELECTION OF ASSISTANTS IN THE NATIONAL GALLERY, MILLBANK (TATE GALLERY).

N.B.—Competitions under these Regulations are open both to men and women. Competitions do not take place at fixed intervals, but are held only on the occurrence of vacancies. The Regulations are liable to alteration from time to time.

I. Candidates must have attained the age of 20 and must not have attained the age of 35 on a date to be fixed in respect of the competition in which they are to take part.

In reckoning age for competition the following allowances will be made, viz.:—

(a) Candidates who have served or are serving in the Army, Navy, or Air Force may deduct from their actual age any time during which they have so served.

(b) Candidates who have served in any established civil situation to which they were
