The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Comare missioners of His Majesty's Treasury, viz.:-

REGULATIONS FOR THE NORMAL RECRUITMENT OF MALE ASSISTANT PREVENTIVE OFFICERS the Waterguard Service IN OF THE CUSTOMS AND EXCISE DEPARTMENT.

N.B.—These regulations are liable to alteration from time to time.

1. Candidates must have attained the age of 19 and must not have attained the age of 21 on the first day of the examination.

In reckoning age for competition the following allowances will be made:-

i) Persons who have served or are serving in the Army, Navy or Air Force, may deduct from their actual age any time not exceeding seven years during which they have served.

(ii) Candidates who have served in any established civil situation to which they were admitted with the Certificate of the Civil Service Commissioners, may deduct from their actual age any time not exceeding two years which they may have spent in such service.

. Every candidate must be a natural-born British subject, the child of a person who is or was at the time of death a British subject; provided that exception may be made in the case
