LAND DRAINAGE ACT, 1930.

South-West Sussex Rivers Catchment Board.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a Scheme submitted to him by the South-West Sussex Rivers Catchment Board under Section 4 (1) (a) of the Act, for the transfer to the Catchment Board of all such rights, powers, duties, obligations and liabilities (including liabilities incurred in connection with works) over or in connection with the main river as were immediately before the commencement of the said Act vested in or to be discharged by any drainage authority, and of any property held by the authority for the purpose of, or in connection with, any functions so to be transferred.

A copy of the Order may be seen at all reasonable hours at the Office of the Clerk of the Catchment Board, County Hall, West Street, Chichester, and also at the Offices of the Ministry of Agriculture and Fisheries, 10, Whitehall Place, London, S.W.1.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act, or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

LAND DRAINAGE ACT, 1930.

Cheshire Rivers Catchment Area.

The Minister of Agriculture and Fisheries hereby gives notice that the Cheshire Rivers Catchment Board have made application under sub-section (3) of Section 5 of the Land Drainage Act, 1930, that the statutory map of the Catchment Area be varied so far as relates to the extent of the "main river" by the addition of certain watercourses to the "main river" as at present defined on the map, the said watercourses forming part of the River Gowy Drainage System.

A copy of the Schedule setting out the proposed additions and a plan on the 1-inch scale on which the proposed additions are shown by lines in black colour may be inspected, together

with a copy of the statutory map of the Catchment Area, at the Office of the Clerk of the Catchment Board, St. John's House, Chester, or at the Offices of the Ministry.

Any objection to the proposed variation of the statutory map shall be made in writing and sent by post, addressed to the Secretary, Ministry of Agriculture and Fisheries, at the address mentioned below, within thirty-one days from the date of this notice.

DISEASES OF ANIMALS ACTS, 1894 TO 1937.

Notice is hereby given, in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Order:—

Order No. 5766.

(Dated 4th November, 1938.)

SUBJECT.

I. Applies Part II (Restriction on Movement of Sheep out of a Movement Area) of the Sheep Scab Order of 1938 to the Area described in the Schedule as from the 15th November, 1938.

II. Applies Part III (Double Dipping of Sheep in a Double Dipping Area) of the Sheep Scab Order of 1938 to the Area described in the Schedule during the period 15th November to 17th December, 1938, inclusive.

SCHEDULE.

An area comprising:—

So much of the County of Cardigan as lies within the following boundary, namely:—

Commencing at a point where the Cardigan-Radnor County boundary meets the southern boundary of the Parish of Ysppyty Ystwyth at Esgair Hengae, thence in a generally westerly direction along the southern boundary of the Parish of Ysppyty Ystwyth, to the point at Pont-rhyd-y-groes where it crosses the road running from Ffair-rhos via Tan-y-rhydiau to Ysppyty Ystwyth thence along that road in a northerly direction to the river Ystwyth, thence along the river in a westerly direction to the point near Tyn-y-bedw where the road from Crosswood Park to Ystrad Meurig crosses the river, thence along that road in a southerly direction to the point at Tyn-y-graig where the road meets the railway line running from Trawscoed Station to Strata Florida Station, thence in a southerly direction along that railway line via Strata Florida Station to Tregaron Railway Station, thence along the road leading from Tregaron Railway Station in an easterly direction via Diffws and Frwd-ar-gamddwr to the point where the said road meets the Cardigan-Brecon County boundary at Nantystalwyn, thence in a
