

ROAD TRAFFIC ACT, 1934 (SECTION 1).

SPEED LIMITS IN THE LONDON TRAFFIC AREA.

Notice is hereby given that the Minister of Transport under and by virtue of the provisions of sub-section (4) of Section 1 of the Road Traffic Act, 1934, intends to make the London Traffic (Built-up Areas) (No.) Order, 1938, the effect of which will be that the speed limit under the said Section will apply throughout every length of road specified in the Schedule hereto.

THE SCHEDULE.

London-Penzance Trunk Road (A.30), Egham, Surrey, between St. Jude's Road (Carfax Corner) and a point 100 yards south-west of Bagshot Road (A.328).

London-Portsmouth Trunk Road (A.3), Ripley, Surrey:

- (i) between the west side of Bridgefoot Bridge and a point 175 yards eastwards; and
- (ii) between points 50 yards and 274 yards west of the western boundary wall of Ripley Police Station.

SPEED LIMITS IN THE LONDON TRAFFIC AREA.

Notice is hereby given that the Minister of Transport under and by virtue of the provisions of paragraph (b) of sub-section (4) of Section 1 of the Road Traffic Act, 1934, intends to make the London Traffic (Built-up Areas) (No.) Order, 1938, the effect of which will be—

- (a) that there will be no speed limit under that Section in respect of the length of road specified in the First Schedule hereto; and
- (b) that the speed limit under the said Section will apply throughout every length of road specified in the Second Schedule hereto.

THE SCHEDULES.

FIRST SCHEDULE.

Hampton Court Road (A.308), Middlesex, between Church Grove (B.358), Hampton Wick, and the Lion Gates, Hampton Court.

SECOND SCHEDULE.

Mill Lane, Oxted, Surrey:

- (i) between points 278 yards and 313 yards south of its junction with Hurst Green Road at Hurst Green, and
- (ii) between points 430 yards and 631 yards south of the aforesaid junction.

Staines—Slough Road (B.376), Hythe End, Wraysbury, Buckinghamshire, from the Middlesex-Buckinghamshire County boundary north-westwards for a distance of one mile.
