4. To empower the Corporation as from the date of the transfer to them of the Gainford undertaking upon the lands hereinafter in this paragraph described to continue maintain erect alter improve and renew gas works with all necessary machinery and apparatus and thereon to manufacture and store gas and work up and convert residual products (that is to say):---

A piece of land situate in the parish of Gainford in the rural district of Barnard Castle known as the Gas Works and containing 570 square yards or thereabouts bounded on the south by the River Tees, on the north by the Green, and on the east and west by lands and hereditaments belonging to Robert Holmes Eddleston.

5. To empower the Corporation upon the lands hereinafter in this paragraph described to erect maintain alter improve and renew gas holders with all necessary machinery and apparatus and thereon to do all such acts as may be proper for storing gas and supplying gas (that is to say):—

provisions of the Gasworks Clauses Acts 1847 and 1871 and the Acts amending the same, and to repeal alter amend extend or apply all or some of the provisions of the Darlington Local Board Act 1854 the Darlington Local Board Act 1861 the Darlington Extension and Improvement Act 1872 the Darlington Orders 1883 to 1906 the Borough of Darlington Order 1914 the Darlington Gas Order 1926 the Darlington Gas Order 1932 the Darlington Gas Order 1936 the Darlington Gas Order 1937 and any other Act or Order relating to the gas undertaking of the Corporation.
